3. Approval of the Minutes of the Parish Council Meeting held on October 8th 2019

It was proposed: G.Francis, seconded: D.Foote and <u>resolved</u> to approve and accept the minutes.

5. Recreation Field

R.Savery reported that she would be inspecting the field within the next few days. H.Cartledge-Claus reported that someone had used fireworks in the field. This would be monitored for any future abuse. D.Foote reported back that some residents had suggested making the field more user friendly. Members of the Council noted the suggestion.

6. Sir Robert Geffery Memorial Hall

R.Savery reported that the Hall committee needs more members and capacity. The secretary of the committee was in favour of this. A meeting of the committee with the public would be called in the New Year to seek more volunteers. G.Francis confirmed that the defibrillator was progressing. November 26th is the date that the new phone line to the Hall would be installed.

7. Village Playground

The Chairman reported that the bottom wall of the playpark was in need of repair. Part of the wall had collapsed. The Chairman had made the area safe. Fencing would be put along the wall until repairs had been completed.

8. Village Street Cleaning

The Chairman reported that the village was looking clean. P.Lamerton was completing repairs around the village as part of his duties.

9. Climate Change: update from working group.

H.Cartledge-Claus reported that the youth group were preparing posters and engaging with residents. G.Francis repoted back from the last Community Network Panel meeting that Landulph Parish Council had produced a statement of intent for tackling Climate Change. It was hoped that Landrake Parish Council could follow suit. The youth group were asked to go away and look at producing a statement of intent for the Parish Council. This could be brought back to a future meeting.

10. Cornwall Gateway Community Network Panel: update

G.Francis reported that the Parish Council needed to bring back to the Panel meeting on December 4th, possible locations to use a mobile speed activation sign, that was not on the A38. It was agreed to nominate the location of Pound Hill.

11. Public Footpaths in the Parish

D.Foote reported that one of the public footpaths was overgrown and that there was concern that the last footpath hrough the Parish was being lost. J.Foot CC reported that he would enquire with Cornwall Council if any funding was available to deal with this.

The Chairman asked if members had any ideas or options for future uses. This item would be deferred until the March meeting.
