Section 14(2) of the Road Traffic Regulation Act 1984 (RTRA 1984)

Temporary Prohibition of Traffic Notice

The Cornwall Council hereby gives notice under Section 14(2) of the Road Traffic Regulation Act 1984 prohibiting the use by traffic over an area of highway being Road From School Road To Notter Bridge House Landrake between grid reference SX3813460788 and the junction for Highertown Park. The notice shall come into force on the 1st February 2021 for a period of up to 5 days, however, it is expected that the works will be completed by the 5th February 2021.

The prohibition will be in force between the hours of 0730 and 1700 on a daily basis weekdays only

The Council is satisfied that the notice is needed because works are being executed on or near the road to carry out tree height clearance works.

The restrictions imposed by this notice shall remain in force on such days and during such times as the appropriate traffic signs are displayed. In this order "traffic sign" means a sign of any size, colour and type described or authorised under or having effect as though prescribed or authorised under section 64 of The Road Traffic Regulation Act 1984.

While the Notice is in operation traffic, including bicycle movement, along the highway specified in paragraph 1, will be temporarily restricted. No personnel, except upon the direction of a police constable in uniform, cause or permit any vehicle or pedal cycle to enter on, proceed or wait in the length of highway described above.

Nothing in the Notice will apply to:

Any personnel on official duty, or any vehicle or person authorised by and with the permission of Cornwall Council.

Any vehicle being used for the purposes of an undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which necessitate the bringing of vehicles into the section of highway to which this order applies.

Traffic associated with the works required within the highway specified above.

An alternative route will be available for use while the notice is in force being A38 From J B3249 To J B3271, A38 Between Quay Road And Liskeard Road, Road From Junction West Of New Road Terrace To School Road, School Road


