The Chairman opened the meeting at 19:02hrs.

Open forum and Cornwall Councillor report

Three of the members of the public attended the meeting in respect of the Bullers Arms and their request for the Parish Council to nominate the pub as an Asset of Community value.

Updates from Cornwall Councillor Martin Worth.

- Use of a Newquay Hotel for asylum seekers: At the weekend Cornwall Council was surprised to • discover, how commandeered the Home Officer, a hotel in Newguay has been utilised to host refugees. CC Martin Worth refereed to Steve Double MP's statement. (See appendix 1i). He does not know yet whether the refugees are economic refugees, but the council has been assured this would only be for the winter and wouldn't have any impact on the holiday seasons. Cornwall Council welcome the refugees, but this was not anticipated.
- Cornwall Council Finances: The Autumn statement is due on 17th November. All statutory and • non-statutory services from April next year are being reviewed.
- **County deal:** On hold until 17th November 2022. .
- Spaceport Cornwall (Newguay Airport): An event is planned for the near future to launch • Cosmic Girl from Newport Airport.
- Transport: Cllr G Francis asked CC Martin Worth on whether Highways England should cover the costs for the Tamar Bridge. CC Martin Worth responded Cornwall Council's new portfolio holder for transport, Connor Donnithorne, will be working with the consultants as part of the business case to present to the government for funding.

The Bullers Arms: Request to register as an Asset of Community Value (A.I.6) 85. Cllr Gingell said he had spoken with the landlord and was told for financial reasons they have decided it is cheaper not to open but to continue paying the rent.

The meeting was opened to the members of the public

A question was raised over the Neighbourhood Development Plan (NDP) and the planning protection for the pub. The response from the Councillors was the NDP was not set in stone.

Comments were raised from members of the public that the closure of the Bullers Arms would be at the detriment of the community, and it has happened at the worse time possible – just after the pandemic.

CC Martin Worth joined the discussion and drew on his experience as Chairman of Landulph Parish Council, where they have been involved in registering public houses as Assets of Community Value. CC Martin Worth said it was important to get the facts and determine that there is community support.

The Councillors discussed the position of the Bullers Arms and it was agreed not to proceed at this time but keep this as a standing item on the agenda and to monitor the situation.

Finance (A.I.7) 86.

To note the Council's bank balance: It was noted the balance in the Unity Trust bank account a) was £22,587.45.

To review the Clerk's budget report, collated following a finance review meeting with the b) Finance Working Group, and to:

(i) approve the budget for 2023-24 and

(ii) approve the recommended precept submission

The Councillors reviewed the budget report. See appendix 2

Cllr Owen updated the Councillors on the finance review meeting, that during the meeting the Clerk and Councillors were mindful that, due to the current climate, the precept should not be raised for the next financial year, particularly as the Council has sufficient reserves.

Cllr Francis gueried whether the tax base accounts for the development in Dolbeare.

It was proposed by Cllr Gingell, seconded by Cllr Walker and unanimously agreed by all Councilors to purchase the signs from SafetySigns4Less.

Photographs taken by Cllr Gingell of recent village maintenance works were displayed on the overhead projector. The jubilee plaque has been installed and bollards have been cleaned.

Environmental Sustainability Working Group (A.I.12) 91.

Cllr Matters said due to Wifi issues the last meeting had to be cancelled. There has been a decline in membership of the group.

92. **Community Network Panel** (A.I.13)

Cllr Francis provided an updated on the Cornmunity Network Panel meeting held on 2nd November 2022 and the proposals for the Community Area Partnerships (CAPs). Slides presentations from the meeting were circulated to the Councillors. These changes are being proposed in order that the larger areas may be eligible for future government funding through the Shared Prosperity Fund (Levelling Up).

Following the meeting, Cllr Francis sent an email to all Councillors outlining the conclusions from the meeting, as detailed below:

- There is no way to stop the reduction of numbers of CNPs (19) to Community Area Partnerships (CAP) - (12)
- The Cornwall Gateway will be combined with Liskeard and Looe to create a Cap with 29 • parishes and 11 Cornwall councillors - representing over 65000 people - second largest in Cornwall. Part of the rationale for this is the A38 affecting both area.
- Any comments on the proposed changes must be received by 15/11/22.

Issues raised: the new proposals reduce the voice of local councils (we go from one in 12 to one in 29). This risks the meetings being completely unwieldy and inoperable. Also, there is a proposal for each Cap to receive £400k, but this discriminates against those with more people including our proposed CAP. There is also a concern that the CAPs will be under-resourced as there is much more work involved in setting up the new scheme and no more Cornwall Council staff appear to be dedicated to it. Also, there is a proposal for Community Chest funding (presently under control of our Cornwall Councillor) to be pooled across the region, which gives us much less local access to it.

Cllr Francis drafted a response raising the Parish Councils strong concerns over the changes. The response was circulated by email to the Councillors. It was proposed by Cllr Gingell, seconded by Cllr Walker and unanimously agreed by all Councillors to submit the response drafted by Cllr Francis. See appendix 3

Appendix 1: Updates from Cornwall Councillor Martin Worth

i) Steve Double MP's Statement on Home Office use of a hotel in Newquay

"We all know that one of the biggest challenges facing our country at the moment is the number of migrants and asylum seekers coming to the UK."

"This was brought home to Cornwall over the weekend with confirmation that the Home Office is using a Newquay hotel to house a limited number of migrants and asylum seekers."

"This is a national issue and each part of our country must do its bit to help."

"Cornwall has a long and proud tradition of welcoming people seeking refuge, most recently with the commendable efforts made by our people and communities to help those displaced by Putin's invasion of Ukraine via the Homes for Ukraine scheme."

"However the move by the Home Office does raise a number of concerns. Over the last two days I have been in touch with Home Office Ministers, the Leader of Cornwall Council and local councillors, to ensure these people both get the support they need and that the Home Office takes steps to properly process them and take further action as required."

"Firstly, I have made it clear that we expect the Home Office to process applications as quickly as possible to ensure those who are genuine refugees get the support they need and are able to move on to the next stage of their lives in the UK. Equally it is important that the Home Office identify those who are not refugees and that these people are repatriated to their own countries."

"Secondly I have asked that resources be made available to Cornwall Council to ensure that while these additional people are living here, there is no impact on our already stretched local services."

"Thirdly I have asked for a commitment from the Home Office that no hotel will be used in this capacity beyond the end of winter so as to not impact on our important tourist season."

"I will continue to work with all involved to ensure that those who need our assistance get it in a prompt and timely manner while ensuring there is minimal impact on our local communities."

ii) Spaceport Cornwall

The UK will become the first country to launch satellites into orbit from Europe.

"Cornwall Council's leader has welcomed the arrival of a converted Boeing 747 which will soon take off from Newquay Cornwall Airport in the first space launch from the UK.

Virgin Orbit's modified Boeing 747 launch vehicle arrived at Spaceport Cornwall, Cornwall Airport Newquay, this week.

'Cosmic Girl' will carry seven payloads into Lower Earth Orbit from Cornwall via the LauncherOne rocket on the 'Start Me Up' mission, Virgin Orbit's first international launch.

The first launch will take place from Spaceport Cornwall in the south-west of England. It will be what is known as a 'horizontal launch'." (<u>https://www.localgov.co.uk/Cornwall-Council-set-to-host-first-UK-space-launch</u>)

Appendix 3: Landrake with St Erney Parish Council's response to the proposed changes for Cornwall **Community Network Panel.**

Landrake with St Erney Parish Council have considered the proposed replacement of the CNP with Community Area Partnerships, and have the following comments :

- Allocation of funding to the CAPs should be on a per capita basis, where the larger areas get more funding. As drafted, the Cornwall Gateway + Looe and Liskeard CAP will be materially disadvantaged by the £400k fixed amount. Some weighting should also be given for those areas which have higher levels of poverty than others.
- Cornwall Council must ensure that there are sufficient staff available to both implement the new arrangements and maintain them. Currently there are only 11 Officers but 12 areas proposed.
- External Funding if part of the rationale for combining the Cornwall Gateway and Liskeard / Looe is the effect of the A38. The Parish Council strongly believes that the new CAP and Cornwall Council need to adopt a formal policy of seeking external funding from National Highways or elsewhere in Central Government to remove the unfair and discriminatory tax on the local population due to the Tamar Crossings (Bridge and Ferry)
- Community Chest the Parish Council strongly believes this must remain under the control of our local Cornwall Councillor, and not merged into some anonymous funding pool.
- A cabinet member should be assigned to be responsible for each CAP currently there are no local Cabinet members so there is a risk we are unrepresented.
- Policy B11 there must be a right for local councils to be engaged and consulted at all times this should be a given, not a "nice to have".
- The existing Highways schemes should go ahead as decided by the current CNPs in December, and this should not be revisited as part of the changes.

Overall the changes seem to place a greater emphasis on Town and Parish councils increasing their responsibilities, but there is a real risk that the towns and parishes will have their voices reduced as part of the change to such large and potentially unwieldy organisations.

The same level of input for each Parish Council should be preserved throughout the proposed changes. The existing CNP has been a beacon of success for localism, and has worked extremely well in a constructive and collaborative way.
