Open forum and Cornwall Councillor report

Update from Cornwall Councillor Martin Worth

- Space launch from Newquay airport: Last night the launch of the first satellite from UK soil is due to take place from Newquay. Virgin Orbit's 'Cosmic Girl', a repurposed jumbo jet, took off from Newquay airport after 10pm yesterday.
- Cornwall Devolution Deal: The consultations regarding the County Deal have commenced. Cornwall Council's 'Let's Talk Cornwall' gives details about the future of levelling up. The consultation runs until 17th February 2023. There will be a series of public meetings, including one on 26th January 2023 in Saltash Guildhall. CC Martin Worth described the deal as one of the most important things that will happen in Cornwall.
- **Speed limits:** 20mph speed limits are being rolled out across Cornwall. 30mph limits will be changed to a 20mph limit. Over 9000 people have been prosecuted in Cornwall for driving over the 20mph limits.
- Housing: There was an Economic Growth and Development Overview and Scrutiny Committee
 meeting today. There was vote on options for tackling Cornwall's housing crisis. There are currently
 717 families in temporary accommodation and 90 rough sleepers..
- Tamar Bridge and Torpoint Ferry Joint Committee: CC Martin Worth is joint Chair of this committee. Fares have recently gone up. More people have been working from home so revenues are down.

Proposals for traffic restrictions (yellow lines) on Church Street / Tideford Road - EDG2106 SN02

CC Martin Worth had another meeting to attend to be said he would stay as long as he could. He was aware that the members of public attending had comments regarding the proposals for traffic restriction along Church Street and Tideford Road and said he would stay to answer questions. Summary of comments raised:

- Parked cars on Church Street: Comments were raised that the residents have self-policed the area
 in front of their properties and the previous farmer used to put notes through their doors when he
 needed to get past.
- CC Martin Worth background of involvement in the project: CC Martin Worth was asked if he was related to current tenanted farmer and was accused by a member of public of having a conflict of interest. CC Martin Worth confirmed the farmer is his brother-in-law, but this has no bearing in him supporting the Parish Council in their aims to address the issues of safety traffic in the parish. The parking issues in Landrake have been a concern since before he was elected as Cornwall Councillor in May 2021. CC Martin Worth became directly involved in the project in May 2021 when he requested a visit by Saltash Fire Brigade in June 2021. A video was recorded which clearly evidenced the fact that parked vehicles prevented the Emergency Services from having a safe passage. The video was posted on the local Landrake Facebook page and the Parish Council was updated. Following this incident, the Parish Council proceeded with its request to the Cornwall

Community Gateway Network Panel for funding. Based on the Emergency vehicle evidence and the fact the problems were still continuing CC Martin Worth supported the application. CC Martin Worth's brother in law did not become a tenant farmer of Markwell Farm, which is accessed via Church Street, until September 2022.

- Communication and lack of communication: Residents of Church Street said up until now they were not aware of the proposals. One attendee said the Parish Council should have put a letter through their doors. Cllr Dr S Walker responded the Parish Council did a survey with parishioners which was distributed to every household.
- CIIr M Gingell's response to Parish Council's decision: The problem hasn't just materialised over the last two years. It has been an issue for a long time. Prior to 1980, Treluggan Quarry was a major quarry and HGV lorries used to go along this route, estimated to be around 20 to 30 lorries a day when they were at their peak. Most lorries are 2.47 metres wide, the same as an agricultural vehicle. The proposals have been discussed and minuted in Parish Council meetings. The Parish Council meetings are always public meetings and there are always open forums in the meetings. Many parishioners and businesses have requested action is taken.

Other comments received:

- **Alternative parking:** Most families have more than one vehicle. What are the Parish Council's plans regarding alternative parking measures?
- Concerns relating to parking issues in other areas of Landrake: If yellow lines are introduced would this have a detrimental effect to the parking issues in other areas of Landrake.
- The position and length of the lines were queried: The proposals were displayed on the overhead projector. Cllr Gingell responded the yellow lines would go over where the white lines currently are and would only expand another two metres further (the loss would be a maximum of two cars).
- Farming practices: Is some of the issue due to the number of vehicle movements from the farm. Could the farmer access the farm via an alternative route. Cllr Gingell responded there is no alternative route, and the parking is not just an issue for the farmers, it is also an issue for local businesses and emergency services.
- Access to the village shop: Concern raised from owners of the village shop where its customers would park.
- Enforcement measures: People would still park on the yellow lines.

To receive apologies for absence (A.I.1)

Apologies received from Cllrs P Mathers, and P Barton.

- Access to the church: A query was raised regarding the disabled access by the gate to the church.¹
- The consultation process: Comments were raised that the Parish Council made its decision to pursue with the proposal before the consultation process took place. The Public Consultation Process as described on the public notices is open until Jan 13th. Cllr Gingell encouraged parishioners to comment directly to Cornwall Council regarding their concerns on the yellow lines before the deadline. Comments made in this meeting would also be taken into account in making a decision.
- Parish Council contribution towards the scheme: The £4,000 contribution would be better spent in other ways. There is currently a cost of living crisis.

20:22hrs: The Chairman closed the public forum adding members of the public could stay for the meeting if they wished but the meeting would not be open for public discussion.

(iii) Update on Cornwall Council planning decisions

During the Parish Council meeting on 11th November 2022, the Parish Council voted to support planning application PA21/08729, Bullers Park, however the following Cornwall Council Planning Officer has recommended refusal of the application.

See communication received below:

"The proposed development is for the change of use of a stable building into a holiday unit. The stable to be converted was granted permission on 10th January 2022 (under PA21/08729) and is therefore a very new structure and does not appear to have been used for the purpose it was originally built. It is not considered that the fact the application is for the conversion of an existing building should be given any significant weight.

The site is located within the open countryside, accessed by a network of single track, unlit roads with no pavement and the nearest point of public transport located over a mile away. The site is not considered to be sustainably located, being positioned on agricultural/equestrian land with visitors being predominantly reliant on the use of private motor vehicles contrary to Policy 5.3 of the Cornwall Local Plan which refers to the provision of new tourism accommodation.

In light of the above, I intend to recommend the application for refusal.

The Chairman advised planning application PA21/08729, Bullers Park, has now been withdrawn.

The planning application was already submitted to the local planning authority, and once it will be validated by them it will be possible for anyone to comment on it via the council's planning website.

You are more than welcome to share provided details with any party that would be interested in this application. Regarding the health concerns, all applications are in full accordance with ICNIRP guidelines (an internationally and nationally government recognised organisation) and have an ICNIRP declaration submitted as part of the application.

As part of the application the surrounding area of the proposed site was fully investigated, and it was considered that the proposed site is the most viable for the proposed equipment. Thank you for your email and attached pre-application consultation letter, site plans and document containing frequently asked questions in relation to the proposed radio base installation at your proposed site (ID CRN25410, School Road, Landrake St Erney).

The Parish Council is not scheduled to meet officially until Tuesday 10th January 2023. An informal Zoom meeting was held on Thursday 8th December 2022. Those Councillors present felt the suggested site is completely inappropriate and unacceptable.

There are several reasons the parish councillors felt the community in Landrake with St Erney would not be in support of the proposed location:

The location would be in a particularly dangerous location.

- The siting of the mast would potentially cause visual impairment for drivers existing the village.
- The structure would be distraction for drivers on the A38. There are already safety concerns on what is an extremely hazardous trunk road. This stretch of road is rated one of the most dangerous roads in the country.
 - The proposed installation of a 20m high slim-line monopole, supporting 6 no.
 antennas, 1 no. wraparound equipment cabinet at the base of the monopole, 2 no.
 equipment cabinets, 1 no. electric meter cabinet, and ancillary development thereto
 including GPS 1 no. module would be an unsightly eyesore for the entrance to the
 village.
 - The Parish Council is in discussions with National Highways regarding Highway
 Improvements. This piece of land may be part of the proposed A38 Safety package.
 - Residential properties are very close to the proposed location. There are health and safety concerns for the neighbouring properties.

Whilst the Parish Council supports the need to make sure residents in the parish have access to 4G and 5G networks, the Council's thoughts are, with the exception of 'the land to the north of Quarry Lane' that the listed sites are not suitable. This is the initial view of the Parish Council and a formal response can be given after the next Full Council meeting on 10th January 2023.

We have some questions regarding how this site meets the requirements of existing planning laws -

National Planning Policy Framework (publishing.service.gov.uk)

Paragraph 115 of the National Planning Policy Framework (NPPF) states "The number of radio and electronic communications masts, and the sites for such installations, should be kept to a minimum consistent with the needs of consumers, the efficient operation of the network and providing reasonable capacity for future expansion. Use of existing masts, buildings and other structures for new electronic communications capability (including wireless) should be encouraged. Where new sites are required (such as for new 5G networks, or for connected transport and smart city applications), equipment should be sympathetically designed and camouflaged where appropriate." Please provide evidence that this is the case.

Paragraph 117 of the National Planning Policy Framework (NPPF) states "Applications for electronic communications development (including applications for prior approval under the General Permitted Development Order) should be supported by the necessary evidence to justify the proposed development." Evidence is required to justify the proposed development (CRN25410) and alternative more appropriate locations should be sought.

In your letter you mentioned consulting with local stakeholder groups, presumably you therefore have no objection to the plans for Clarke Telecom's proposed site, on the document titled 'Site Plan Rev A', being published on the Parish Council's website and shared on the local community Facebook page. It would also be advisable for you to consult with local organisations such as 'Safe38' and 'Sir Robert Geffery Memorial Hall'.
